et seq.) owned by Debtor or in which Debtor has any interest (collectively, "Trademarks and Trade Names"). All unearned premiums, accrued, accruing or to accrue under insurance policies now or hereafter obtained solely by Debtor and all proceeds of the conversion, voluntary or involuntary, of any real or tangible personal property of Debtor, and/or any other property or rights described herein, or any part thereof, into cash or liquidated claims. All awards or payments, including interest thereon, and the rights to receive the same, which may be made with respect to eminent domain, the alteration of the grade of any street, or any other injury to or decrease in the value of any real or tangible personal property of Debtor and/or any other property or rights described herein, and all other items not specifically set forth herein but which constitute "general intangibles" under the UCC, now owned or hereafter acquired by Debtor; and all cash and non-cash proceeds of the foregoing.

**INVENTORY:** All goods, merchandise and other personal property now owned or hereafter acquired by Debtor and held for sale or lease, or furnished or to be furnished under any contract of service, including, without limitation, raw materials, work-in-process, supplies or materials used or consumed in Debtor's business, and all products thereof, and all substitutions, replacements, additions or accessions therefor and thereto, and all other items not specifically set forth herein but which constitute "inventory" under the UCC; and all cash or non-cash proceeds of all of the foregoing, including insurance proceeds.

<u>DEPOSIT ACCOUNTS</u>: All demand, time, savings, passbook, or similar accounts maintained with a bank or other financial institution, and all other items not specifically set forth herein but which constitute "deposit accounts" under the UCC; and all cash and non-cash proceeds of the foregoing, including insurance proceeds.

**INVESTMENT PROPERTY:** All securities, whether certificated or uncertificated, security entitlements, securities accounts, commodity contracts, or commodity accounts, and all other items not specifically set forth herein but which constitute "investment property" under the UCC; and all cash and non-cash proceeds of the foregoing, including insurance proceeds.

INSTRUMENTS: All negotiable instruments or any other writings that evidence a right to the payment of a monetary obligation, is not itself a security agreement or lease, and is not of a type that in ordinary course of business is transferred by delivery with any necessary endorsement or assignment, and all other items not specifically set forth herein but which constitute "instruments" under the UCC; and all cash and non-cash proceeds of the foregoing, including insurance proceeds.

<u>LETTER-OF-CREDIT RIGHTS</u>: All rights to payment or performance under letters of credit, whether or not the beneficiary has demanded or is at the time entitled to demand payment or performance, and all other items not specifically set forth herein but which constitute "letter-of-credit rights" under the UCC; and all cash and non-cash proceeds of the foregoing, including insurance proceeds.

<u>CHATTEL PAPER</u>: All records that evidence both a monetary obligation and a security interest in specific goods, a security interest in specific goods and software used in the goods, a security interest in specific goods and license of software used in the goods, a lease of

In this paragraph, "monetary obligation" means a monetary obligation secured by the goods or owed under a lease of the goods and includes a monetary obligation with respect to software used in the goods. If a transaction is evidenced by records that include an instrument or series of instruments, the group of records taken together constitutes "chattel paper".

**<u>DOCUMENTS</u>**: All documents of title or receipts of the type described in Section 6A-7-201 of the UCC, and all other items not specifically set forth herein but which constitute "documents" under the UCC; and all cash and non-cash proceeds of the foregoing, including insurance proceeds.

<u>COMMERCIAL TORT CLAIMS</u>: All claims arising in tort with respect to which the claimant is an organization; or the claimant is an individual and the claim arose in the course of the claimants business or profession; and does not include damages arising out of personal injury to or the death of an individual.
