REAL ESTATE DESCRIPTION

Those three lots of land, with all the buildings and other improvements thereon, situated on the southerly side of Park Street and on the westerly side of Rock Point Road in the City of Warwick and State of Rhode Island, laid out and delineated as Lots Nos. 253 (two hundred fifty-three) 254 (two hundred fifty-four) and 255 (two hundred fifty-five) on that plat entitled, "Warwick Neck Park Plat No. 2, Warwick, Rhode Island Belonging to Warwick Neck Building Co. by Shedd & Sarle August 1895", and recorded in the Records of Land Evidence in said City of Warwick in Plat Book 3 at Page 60 and (copy) on Plat Card 127.

Said three lots together form one tract of land bounded and described as follows: Beginning at the northeasterly corner of said tract, at the southwesterly corner of Park Street and Rock Point Road then southerly bounded easterly on said Rocky Point Road 155.65 feet to land now or lately of Carlo Caldarone; thence westerly bounded southerly on said Caldarone land 141.74 feet to land now or lately of Alfred A. Caldarone; thence northerly bounding westerly on said Caldarone land 139.74 feet to Park Street; thence easterly bounding southerly on said Park Street 75.46 feet to the point of beginning.

That certain tract or parcel of land, together with all buildings and improvements thereon, located in the City of Warwick, County of Kent and State of Rhode Island, more particularly described as follows:

Beginning at the northwest corner of land now or formerly belonging to Pasquale Palumbo, thence running westerly on the southerly line of Park Street a distance of TWO HUNDRED (200) feet, thence running southerly at right angles with said Park Street to land now or formerly of James Young, thence with said Young's land easterly to said Palumbo's land, thence northerly with said Palumbo's land to the place of beginning.
