LEGAL DESCRIPTION

That certain parcel of land with all the buildings and improvements thereon situated in the Town of North Providence, County of Providence, State of Rhode Island, bounded and described as follows:

Beginning at a granite bound set in the northeasterly line of Smith Street at the intersection of the said line with the northeasterly line of Angell Avenue; thence turning an interior angle of $55^{\circ} 18'$ against the said line of Angell Avenue and running northeasterly with land now or formerly of Peter Campisano et ux. eighty-six and $65/100$ (86.65) feet to a pipe driven into the ground; thence turning an interior angle of 90° and running northwesterly in the partition between the garage and the green house twenty-five and $95/100$ (25.95) feet to a drill hole in a concrete curb; thence turning an interior angle of $162^{\circ} 38'$ and running westerly with other land of Zacharias P. Rouvelas seventy-one and $64/100$ (71.64) feet to a pipe driven into the ground in the said line of Angell Avenue; thence turning an interior angle of $52^{\circ} 04'$ and running southeasterly in the said street line one hundred fourteen and $73/100$ (114.73) feet to the point of beginning.
