EXHIBIT A

"Pledged Accounts" means the "Construction Account" and the "Debt Service Reserve Account" as defined in the Loan Agreement and specifically identified below.

The "Construction Account" means Account #19051069 in the name of the Debtor held by Citizens Bank of Rhode Island (the "Construction Account Depository") and created under the letter agreement related thereto dated August 29, 2007 from the Debtor to the Construction Account Depository and Fannie Mae.

The "Debt Service Reserve Account" means Account #19051077 in the name of Debtor held by the Citizens Bank of Rhode Island (the "Debt Service Reserve Account Depository") and created under the letter agreement related thereto dated August 29, 2007 from the Debtor to the Debt Service Reserve Account Depository and Fannie Mae.
