ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Cumberland Youth Lacrosse Association
2. The period of its duration is (if perpetual, so state) Perpetual
3. The specific purpose or purposes for which the corporation is organized are:
CYLAX will be affiliated with the Northern RI Youth Lacrosse Association (NRYLAX), and its parent organization, Rhode Island Lacrosse (RILAX), a chapter of US Lacrosse, Inc. As such, the Cumberland Youth Lacrosse Association shall dedicate itself to the best interests of youth lacrosse, with particular emphasis on the organization, promotion, regulation, and development of youth lacrosse in Cumberland, Rhode Island. CYLAX is organized exclusively as a private, non-profit, charitable organization as a qualified amateur sports organization, including, for such purposes, the making of such distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this association shall not, except to an insubstantial degree, engage in any (continued on back of page)

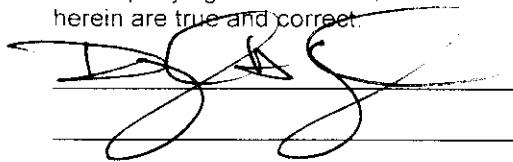
