# ATTACHMENT I TO ARTICLES OF INCORPORATION

#### Article fourth is as follows:

Said corporation is organized exclusively to operate as a social welfare organization as specified in Section 501 (c)(4) of the Internal Revenue Code of 1986.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article third hereof.

Upon dissolution of the corporation, the officers shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purpose of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, education, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under <a href="Sec.501(c)(3)">Sec.501(c)(3)</a> of the <a href="Internal Revenue Code of 1986">Internal Revenue Code of 1986</a>. (or the corresponding provisions of any future United States Internal Revenue Law). as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Superior Court of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
