The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.2 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

6. Additional provisions, if any, not inconsistent with Chapter 7-1.2 which the incorporators elect to have set forth in these Articles of Incorporation:

The corporation elects to have preemptive rights. Any shareholder, including the heirs, assigns, executors or administrators of a deceased shareholder, desiring to sell or transfer such shares

owned by him/her shall first offer it to the corporation by notifying the corporation of his/her desire to sell or transfer by notice in writing, which notice shall contain the price at which

he/she is willing to sell or transfer. The corporation shall, within thirty (30) days thereafter, either accept or reject the offer, but if at the expiration of thirty (30) days the corporation shall

~~not have exercised the right to purchase, the owner of such shares shall~~
be at liberty to dispose of the same at a price not less than that offered to the corporation.
