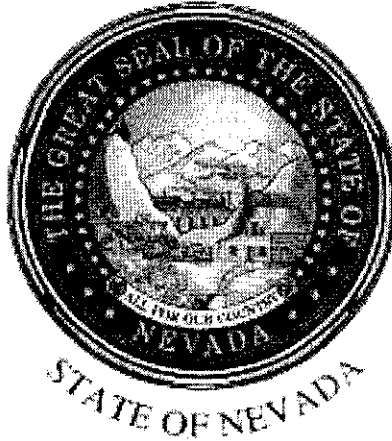


## CERTIFICATE OF EXISTENCE WITH STATUS IN GOOD STANDING
