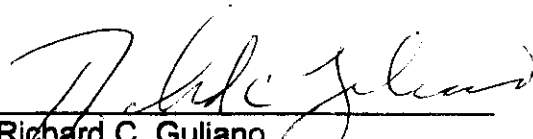
CONSENT RESOLUTION TO DISSOLVE COURT-SUE, INC.
