The purposes for which this corporation is organized and shall be exclusively operated are charitable, educational, religious or scientific purposes within the meaning of section 501(c)(93) of the Internal Revenue Code of 1986 as amended, or the corresponding provision of any subsequent Federal Tax Laws. Specifically the purpose is: to promote islamic education and dialogue, implement job training and social welfare programs in economically depressed areas, provide food, shelter, free healthcare and emergency relief to the poorest communities. Establish a community re-entry program for ex-offenders from jail or prison. Provide assistance to the poor and other persons deserving charity under Islamic law by collecting and distributing obligatory and voluntary charity called Zakat and Sadaqa.
