The corporation retains the right to require that sale of outstanding stock is first offered to the corporation, along with any and all other legal regulations the corporation may set forth.

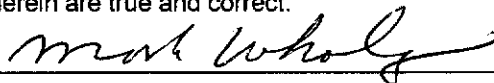
