AN ACT

TO VACATE THE FORFEITURE OR REVOCATION OF THE CHARTER OF TAU OMEGA  
CHAPTER OF TAU EPSILON PHI FRATERNITY, INC.

It is enacted by the General Assembly as follows:

- 1 SECTION 1. The time within which Tau Omega Chapter of Tau Epsilon Phi Fraternity,  
2 Inc., incorporated March 4, 1986 shall file the reports for the years 1986, 1987, 1988, 1989, 1990,  
3 1991, 1992, 1993, 1994, 1995, 1996, 1997, 1998, 1999, 2000, 2001, 2002, 2003, 2004, 2005,  
4 2006, 2007, 2008 as required under the provisions of section 7-6-90 of the general laws of Rhode  
5 Island, 1956, is hereby extended to the 31<sup>st</sup> day of December, A.D., 2008 if said corporation shall  
6 file in the office of the Secretary of State before December 31, 2008, the reports which it should  
7 have filed in the said years and shall pay to the Secretary of State the filing fees therefore, having  
8 previously thereto paid to the General Treasurer for the use of the state such sum as the Attorney  
9 General shall decide should be paid by said corporation as a compromise for the penalty or  
10 penalties for its failure to file such reports then the forfeiture or revocation of the charter of said  
11 corporation shall thereupon, to wit, upon the filing of said reports and the payment of said fees,  
12 be vacated and said corporation shall thereupon be entitled to all of the privileges, benefits and  
13 powers and subject to the same duties and liabilities as though no forfeiture or revocation of its  
14 said charter of its said charter had taken place.
- 15 SECTION 2. This act shall take effect upon passage.
