The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

- The name of the corporation is Haitian-American Partnership of Rhode Island for positive Action - Happari
- The period of its duration is (if perpetual, so state) perpetual
- The specific purpose or purposes for which the corporation is organized are:  
This organization is engaged in establishing a vital link between the Haitian Community in the state of Rhode Island and all appertenant Institutions whether governmental or private so that our Haitian-American constitute access pertinent information regarding their financial social, cultural, educational, sports, health and youth development well being
- Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:  
The Board of Directors are elected for a term of 12 months. The board members whose conduct is in a violation of the Corporation's ideal and goal will be dismissed by a majority vote of the board directors. Board members must attend all meetings. A monthly financial is to be submitted to the president and vice-president on a monthly basis and to the Board of Directions on a quarterly basis. The director and vice president will alternate the Chairmanship of the monthly or quarterly meetings.
