THE UNDERSIGNED, desiring to form a nonprofit corporation in compliance with the requirements of Section 5306 of the Pennsylvania Nonprofit Corporation Law of 1988, hereby certifies that:

3. The Corporation is incorporated under the Pennsylvania Nonprofit Corporation Law of 1988 for the following purposes:

Activities consistent with charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or corresponding provision of any future Federal tax code, including, but not limited to, the following:

- i. To share with the greatest number of people Tiffany's window series "Angels Representing Seven Churches" ("ARSC").
- ii. To provide education about ARSC historical and artistic significance.
- iii. To archive ARSC evolution and journey.
