SPECIFIC POWER OF ATTORNEY

- I, JEAN PIERRE FARHI, of New York, New York, appoint PETER BRENT REGAN, of Middletown, Rhode Island, my true and lawful attorney (hereinafter "my attorney"), with full power of substitution for me and in my name, place and stead, with regard to all matters involving that certain parcel of real property, with buildings and improvements thereon, situated at 85 Mill Street, in the City of Newport, County of Newport, State of Rhode Island (hereinafter the "Premises"):
- 1. <u>COLLECTION</u>. To demand, sue for, collect, receive and give discharges for any rents or other moneys, at any time payable or belonging to me regarding the premises.
- 2. <u>LEGAL ACTIONS AND SETTLEMENTS</u>. To commence, prosecute, discontinue, defend and submit to judgment in any actions and other proceedings concerning the premises as my attorney may deem advisable.
- 3. <u>LEASE AND MANAGEMENT</u>. To lease the premises, or any portion thereof for any term; to give options to lease; to contract for and make repairs, alterations, replacements and improvements to the premises; to employ real estate agents or managers, to take any action with respect to tenants, including notice to quit and ejectment; all upon such terms and conditions as my attorney may deem advisable.
- 4. INSURANCE. To apply for, pay premiums on, and maintain any policies of insurance on the premises which my attorney may deem advisable, including, without limitation, liability, accident, and insurance against loss of or damage to any property, and in the event of any loss, damage or expense thus insured against, to apply for recovery or reimbursement under any such insurance policies and to agree to the determination of the amount of such loss, damage or expense as my attorney may deem advisable.
- 5. <u>PAYMENT OF OBLIGATIONS</u>. To pay any obligations or liabilities incurred by me or incurred by my attorney in the exercise of the powers conferred hereunder.
- 6. AGENTS. To deal with, direct and employ such legal counsel, accountants, agents and employees as my attorney may deem advisable.
- 7. <u>DOCUMENTS</u>. To execute, acknowledge and deliver all instruments and to execute all other documents and do all other acts which may be necessary or proper in connection with the exercise of any of the foregoing powers and for carrying out any powers incidental thereto.

Subject to the foregoing, I give my attorney full power and authority to do every necessary or proper act which I might or could do if personally present, hereby ratifying and confirming all

that my attorney shall lawfully do or cause to be done by virtue hereof.

This power of attorney shall not be affected by my subsequent incompetency.
