THE UNDERSIGNED, being of legal age and in order to form a corporation under and pursuant to the provisions of the Nonprofit Corporation Act of the State of New Jersey, does hereby set forth as follows:

FIRST: The name of the corporation is

ADVISORY CREDIT MANAGEMENT, INC.

SECOND: The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the Nonprofit Corporation Act of the State of New Jersey.

In furtherance of the above named purposes, the corporation shall be organized for the following purposes:

To assist individuals experiencing consumer credit problems through education and counseling about controlling debt and implementing debt management controls, to reduce the incidence of personal bankruptcy by informing the public on personal money management and by assisting low-income individuals and families who have financial problems, to provide educational opportunities for individuals experiencing financial problems consistent therewith, and in furtherance thereof, to operate exclusively within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to the corporation and to make payments and distribution in furtherance of the purposes set forth herein.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office except as authorized under the Internal Revenue Code of 1986, as amended.

The corporation is organized exclusively for charitable, scientific and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, including for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal Tax Code.

The corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, as amended (or the corresponding provisions of any future United States Internal Revenue Law).

THIRD: The address of the initial registered office of the corporation and the name of the registered agent at said address are:

FOURTH: The corporation shall have members and the qualifications will be set forth in the By-Laws of the corporation.

FIFTH: The rights and limitations of the different classes of members will be as set forth in the By-Laws of the corporation.

SIXTH: The term for which the corporation is to exist is perpetual.

SEVENTH: The corporation shall indemnify every corporate agent as defined in, and to the full extent permitted by Section 15A:3-4 of the New Jersey Nonprofit Corporation Act, and to the full extent otherwise permitted by law.

EIGHTH: The method of distribution of assets of the corporation shall be as set forth in the By-Laws of the corporation.

NINTH: The method of electing trustees will be as set forth in the By-Laws of the corporation.

TWELFTH: Upon dissolution or other termination of the corporation, no part of the property of the corporation or any of the proceeds shall be distributed to or inure to the benefit of any of the members, trustees, or officers of the corporation. All such property and proceeds, subject to the discharge of valid obligations of the corporation, shall be distributed to any such organization as the board of trustees may direct; provided, however, that any transferee organization, at the time of distribution, shall qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law). Assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Superior Court of New Jersey of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

THIRTEENTH: The effective date of this Certificate of Incorporation shall be the date of filing with the Secretary of State of New Jersey.

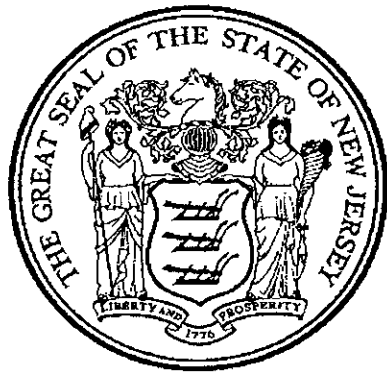
