**Non-Profit Corporation
Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Crown Theological Seminary

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

1. Conduct a Theological Seminar trough the Internet, for but not limited to Pastors and Ministers with 5 or more years in the Ministry for them to learn more about the Bible and Ministerial strategy.
2. Conduct a Christian school of Leadership trough the Internet.
3. Conduct a Christian School of Management and Motivation trough the Internet.
4. Conduct Religious Leadership Seminars in the United States and Abroad.
5. Conduct an adult bible school and training center for Evangelism at our location and trough the Internet.
6. Minister the Word of God Locally and Internationally.
7. Train, support, license and ordain Ministers in The United States and other countries including but not limited to Central and South America and the Caribbean.
8. Recognize Minister that have more than 5 years in the ministry with Religious Honorary Degrees.
9. Promote Worship services through various forms of music ministry, teaching and preaching the principles as taught in the Bible, prayer, The Lord's Supper, Baptisms, and various other elements and types of services;
10. Promote, sponsor and encourage, through the ministries of the organization Christian principles and values that will help to better society;
11. Spread the Word of the Gospel by ministering to people through radio, television, and other forms of mass media.
12. Conduct services in various locations throughout the Providence local and extended area.
13. Conduct any other ministries for edification and evangelistic outreach as the Board of Directors may from time to time initiate.
14. Provide benevolence assistance to those who are in need; including food, shelter, clothing, and other items. To provide charitable assistance to those in need within and without the congregation, vicinity of the church, the nation and the world.
15. Provide Apostolic covering for all those national and international who desire such covering and are accepted into the fellowship as provided and approved by the Board of Directors.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

#1.- EACH DIRECTOR AND TRUSTEE WILL BE ABLE TO SERVE FOR ONE YEAR AND UNLIMITED RE ELECTIONS.

#2.- EACH DIRECTOR AND TRUSTEE MUST BE ACTIVE, PROVIDING SERVICES IN ORDER TO BE CANDIDATE FOR RE ELECTION.

#3.- VOLUNTEERS MAY BE ADDED AT ANY TIME IF NEEDED.

#4.- A MINIMUM OF THREE DIRECTORS AND-OR TRUSTEES MUST BE ACTIVE AT ALL TIMES IN ORDER FOR THIS CORPORATION TO CONTINUE OPEN.

#5.- RE ELECTIONS WILL TAKE PLACE BETWEEN FEBRUARY AND MARCH EVERY TWO YEARS STARTING THE FOURTH YEAR.

#6. THE PRESIDENT IS PERPETUAL/VITALICE UNLESS HE RESIGNES OR IF HE IS FOUND GILTY OF A MORAL SIN ACCORDING TO THE BIBLE.
