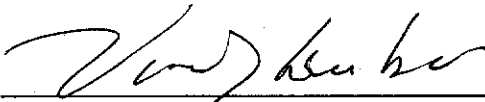

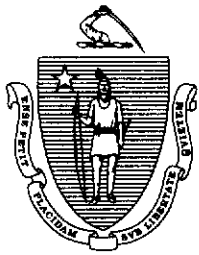

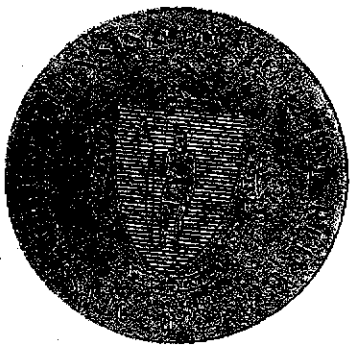

COMMONWEALTH OF MASSACHUSETTS.

In the year One Thousand Nine Hundred and Four

AN ACT To Incorporate the Evening Law School of the Boston Young Men's Christian Association.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows. Section 1. James R. Dunbar, James S. Ames, Samuel L. Bennett, D. Chauncey Brewer, Josiah H. Quincy, Francis S. Sears, George W. Menafley, and their successors, are hereby constituted a body corporate, by the name of the Evening Law School of the Boston Young Men's Christian Association, for the purpose hereinafter named; and they and such persons as shall become members of said corporation shall be and remain a body corporate forever. Said body shall consist of seven members only, and shall have power to fill vacancies within itself: provided, however, that four of said members shall always be members of the board of directors of the Boston Young Men's Christian Association, and shall cease to be members of said body corporate upon ceasing to be members of said board of directors. Four of said members shall be members of the bar; and all persons proposed as members of said body shall be approved by the board of directors of the Boston Young Men's Christian Association before election thereto. Section 2. The purpose of the said corporation shall be to furnish instruction in law, and for the accomplishment of this purpose it may appoint such teachers and lecturers and adopt such form of organization, by laws, regulations and methods of administration as it deems advisable. Section 3. The course of instruction furnished by the corporation shall occupy not less than four years, and to students properly accredited and recommended by a majority of the faculty of said law school the corporation may grant the degree of bachelor of laws. Section 4. The Boston Young Men's Christian Association shall provide the said corporation with suitable rooms and a library, shall pay all expenses of maintaining the said corporation, shall have sole management of its financial affairs, and shall be entitled to all its income. Section 5. This act shall take effect upon its acceptance by the board of directors of the Boston Young Men's Christian Association, and

said association and said board are hereby authorized to do all things set forth
or referred to in this act to be done by it or them.

THE COMMONWEALTH OF MASSACHUSETTS.

In the Year One Thousand Nine Hundred and Twenty

AN ACT To authorize Northeastern College of the Boston Young Men's Christian Association to grant Certain Degrees.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows: Northeastern College of the Boston Young Men's Christian Association may grant the degrees of bachelor of civil engineering, bachelor of mechanical engineering, bachelor of electrical engineering, and bachelor of chemical engineering to students in the Co-operative School of Engineering of Northeastern College who are properly accredited and recommended by a majority of its trustees: provided, however, that the course of instruction furnished by the corporation shall not be entered upon without the completion of a four-year secondary school course, and shall cover not less than four years; and provided, further, that no degree shall be granted to any person who has not taken the full four-year course leading to such degree.

AN ACT authorizing the Trustees of the Northeastern University of the Boston Young Men's Christian Association to grant certain Degrees.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows: The Trustees of Northeastern University of the Boston Young Men's Christian Association, a corporation organized under general law, are hereby authorized to confer such degrees as are usually conferred by colleges and universities in this Commonwealth, except medical and dental degrees and degrees of Bachelor of Science (B. S.) and Bachelor of Arts (A. B.), and to grant diplomas therefor.

AN ACT authorizing the Boston Young Men's Christian Association and the Northeastern University of the Boston Young Men's Christian Association to make Contracts to Pay Annuities.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. The Boston Young Men's Christian Association, a corporation established by law in this commonwealth, may, in consideration of the receipt of funds to be devoted to the purposes for which it is incorporated, bind itself to pay fixed yearly sums, or the whole or a part of the income accruing from such funds, in one or more payments each year to such person or persons as may be agreed upon, for a term of years or for the life of such person or persons. Any funds so received by said corporation shall be held by it in trust, upon such terms and conditions as may be agreed upon by it and the person or persons from whom such funds were so received, until the termination of the agreement under the terms of which such funds were so received.

SECTION 2. The Northeastern University of the Boston Young Men's Christian Association, a corporation established by law in this commonwealth, may, in consideration of the receipt of funds to be devoted to the purposes for which it is incorporated, bind itself to pay fixed yearly sums, or the whole or a part of the income accruing from such funds, in one or more payments each year to such person or persons as may be agreed upon, for a term of years or for the life of such person or persons. Any funds so received by said corporation shall be held by it in trust, upon such terms and conditions as may be agreed upon by it and the person or persons from whom such funds were so received, until the termination of the agreement under the terms of which such funds were so received.
