The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

The Financial Clinic, Inc. is a charitable organization that is organized for the specific purpose of providing

charitable organization is to use the advancement of financial education to lessen the burdens of

Internal Revenue Code.

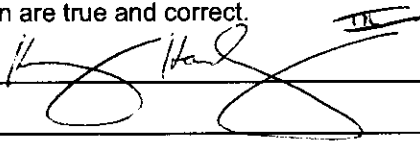
