**EIGHTH AMENDMENT TO THE AMENDED AND RESTATED
CERTIFICATE AND AGREEMENT OF THE LIMITED PARTNERSHIP OF
RAND ASSOCIATES**

THIS EIGHTH AMENDMENT to the Amended and Restated Certificate and Agreement of the Rhode Island Limited Partnership of Rand Associates (the "Partnership"), originally filed with the Secretary of the State of Rhode Island on March 23, 1981 and thereafter amended and restated in accordance with the terms and conditions thereof, is entered into by the undersigned as of the 30th day of April, 2009.

WHEREAS, on January 31, 2009, Raymond J. Hill, a limited partner of the Partnership, died;

WHEREAS, at the time of his death, Raymond J. Hill was the owner of one Unit in the Partnership;

WHEREAS, the Estate of Raymond J. Hill has requested that the interest of Raymond J. Hill in the Partnership, to wit, one Unit, be assigned and transferred to his surviving spouse, Elizabeth Hill; and

WHEREAS, Elizabeth Hill has accepted the assignment and transfer.

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Amended and Restated Certificate and Agreement of the Partnership are amended as follows:


1. The Estate of Raymond J. Hill hereby resigns and withdraws from the Partnership, and assigns its limited partnership interest in the Partnership, to wit, one Unit, to Elizabeth Hill, as reflected in the Schedule A attached hereto.
2. The Partnership and its General Partners have approved the substitution of Elizabeth Hill as a Limited Partner in the Partnership in the place of the Estate of Raymond J. Hill.
3. Elizabeth Hill, in her capacity as a Limited Partner of the Partnership, hereby assumes the duties and liabilities of the Estate of Raymond J. Hill with respect to the Partnership, and accepts all the terms and provisions of the Amended and Restated Certificate and Agreement of Limited Partnership of the Partnership.
