I. THE OPERATING AGREEMENT OF THE LIMITED LIABILITY COMPANY (HEREINAFTER

REFERRED TO AS THE "COMPANY"), AS ON FILE WITH THE COMPANY'S RESIDENT AGENT AND AS MAY FROM TIME TO TIME BE AMENDED (HEREINAFTER REFERRED TO AS THE "OPERATING AGREEMENT"), PROVIDES THAT NO MANAGER OF THE COMPANY (AND NO MANAGER'S AGENTS, PARTNERS, EMPLOYEES, COUNSEL OR AFFILIATE (AS DEFINED IN THE OPERATING AGREEMENT)) SHALL BE LIABLE, RESPONSIBLE OR ACCOUNTABLE IN MONETARY DAMAGES OR OTHERWISE FOR BREACH OF ANY DUTY PROVIDED FOR IN SECTION 17 OF CHAPTER 7-16 OF THE GENERAL LAWS OF RHODE ISLAND, 1956, AS AMENDED (HEREINAFTER REFERRED TO AS THE "ACT"), OR FOR ANY OTHER ACTION TAKEN OR FAILURE TO ACT ON BEHALF OF THE COMPANY EXCEPT AS OTHERWISE MAY BE SPECIFICALLY PROVIDED IN THE OPERATING AGREEMENT OR REQUIRED BY SECTION 18 OF THE ACT.

II. THE OPERATING AGREEMENT ALSO INCLUDES PROVISIONS FOR THE PURPOSE OF INDEMNIFYING AND HOLDING HARMLESS, TO THE FULLEST EXTENT PERMITTED BY THE ACT AND ALL OTHER APPLICABLE LAW, EACH MEMBER OF THE COMPANY; EACH TRANSFEREE OF INTEREST IN THE COMPANY; EACH CURRENT OR FORMER MANAGER OF THE COMPANY; EACH DIRECTOR, OFFICER, AGENT, PARTNER, EMPLOYEE AND COUNSEL OF THE COMPANY; AND THE AFFILIATE OF EACH SUCH PARTY (HEREINAFTER REFERRED TO AS "INDEMNIFIED PARTY").

III. THE MANAGER OR MANAGERS OF THE COMPANY MAY AUTHORIZE THAT
AGREEMENTS BE ENTERED INTO WITH EACH INDEMNIFIED PARTY FOR THE PURPOSE
OF INDEMNIFYING AND HOLDING HARMLESS EACH INDEMNIFIED PARTY TO THE
FULLEST EXTENT PERMITTED BY THE ACT AND ALL OTHER APPLICABLE LAW.
