AGREEMENT TO FORM FINANCIAL INSTITUTION

Coastway Credit Union, a credit union organized under the laws of the State of Rhode Island, has adopted this Agreement to Form of COASTWAY COMMUNITY BANK, a financial institution, pursuant to the plan of mutual charter conversion filed by Coastway Credit Union with and approved by the Director of Business Regulation or his or her designee, and hereby agrees that:

That the financial institution shall be known by the name of COASTWAY FIRST: COMMUNITY BANK.

SECOND: That the financial institution shall be formed for the purpose of engaging in the business of a financial institution, with all of the powers, rights and privileges and subject to all of the duties, restrictions and liabilities applicable to financial institutions set forth in Title 19 of the General Laws of Rhode Island, as amended.

That the address at which the financial institution's business is to be transacted and its THIRD: main office shall be located is One Coastway Plaza, Cranston, Rhode Island 02920.

FOURTH: That the financial institution does not intend to exercise trust powers.
