4. That the Receiver's request for fees and expenses accrued to date are hereby approved and that Receiver is hereby directed to pay said fees and costs in the amount of \$ 19,827.50;



8. That this proceeding is now closed and may be reopened only upon the filing of a Motion.



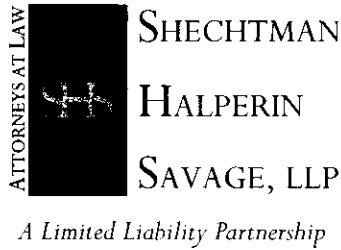
