ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

benefit of any director or officer of the corporation or any private individual; no substantial part of the
activities of the corporation shall be carrying on of propaganda or otherwise attempting to influence legisla-
