Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Clear Objectives, Inc.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

Clear Objectives will provide Traumatic Incident Reduction (TIR) and selected other methods from the system developed by Dr. Frank Gerbode in 1986, specifically tailored to reducing the symptoms of PTSD or preventing them through effective critical incident debriefing. Persons who have been traumatized, either by being the victims of violent crime or through being witnesses to traumatic situations (i.e.: Veterans with PTSD) need specialized handling, and this population has been on the increase. Additional counseling, in terms of reconstructing a productive and happy life, would then also be provided through a program called "Schema", as written by Henry Whitfield. These programs have proven very effective, but are not yet widely available to an underserved population.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

AT THIS TIME, CLEAR OBJECTIVES, INC. WILL BE GOVERNED BY A SINGLE AGENT: AT A FUTURE DATE, THE ARTICLES OF INCORPORATION WILL BE AMENDED TO PROVIDE FOR AN EXECUTIVE BOARD.
