ADDENDUM TO ARTICLES OF INCORPORATION OF KIDS JUNCTION, INC.

6. Provisions, if any, for the regulation of the internal affairs of the corporation:

In the event that any shareholder, or the respective heirs, administrators or executors of any shareholder shall desire to sell the whole or any portion of his or her shares of this corporation, he or she shall, before offering the same for sale to any other party, give notice in writing to the corporation of his desire to sell, and offer said shares to that corporation. Within (20) twenty days from receipt of said written offer, the Board of Directors shall decide whether to accept said offer. If the Board of Directors elects to accept said offer, they shall consummate said purchase within (20) twenty days of their notifying the shareholder of said acceptance. If the Board of Directors elects not to purchase said shares, then it shall notify said shareholder of their rejection within the (20) twenty day time period, and said shareholder shall be free to offer said shares to the public for sale.

The purchase price offered to the corporation for said shares shall be the price offered this shareholder in writing by a bona fide prospective purchaser of said shares.
