A notice for the 2009 annual report was mailed to the Registered Agent at the address listed on the Application for Registration for the above-mentioned entity (Robert M. Saunders 42 Bradford Street Bristol, RI 02809). The notice was returned to this office by the resident of 42 Bradford Street explaining that (he/she) had never consented to have (his/her) address used as the registered office, knew nothing about the limited liability company and that there is no business conducted on the premises.
