THROUGH THE BOARD OF DIRECTORS. THE PRICE SHALL BE SET BY THE MARKET
VALUE THROUGH TWO INDEPENDENT ARBITRATORS, IF THE CORPORATION DOES
NOT EXERCISE THEIR RIGHT TO PURCHASE, THEN THE SELLER SHALL POST THE
STOCKS TO AN OUTSIDE THIRD PARTY APPROVED BY THE BOARD.
