3. That the Temporary Receiver's administrative claim in the amount of Ten Thousand, Seven Hundred and Seventy Nine Dollars and Forty Eight Cents (\$10,779.48) for all fees and expenses from the funds on hand in the receivership estate is hereby allowed and the Receiver is authorized and directed to pay himself on account of said allowed administrative claim from the funds in the Receivership account.

4. That said Temporary Receiver is hereby authorized to return the balance of all Respondent's property, books and records and any other outstanding assets held.

9. That said Temporary Receiver is hereby discharged and the Receivership Bond ordered cancelled.

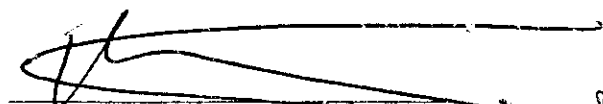
