Non-Profit Corporation Articles of Incorporation

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

This entity is organized exclusively for charitable purposes, specifically to raise and distribute funds for other military charities and organizations that qualify under section 501(c)(3) of the Internal Revenue Code.

Mailcall's mission is to provide an organized fundraising mechanism for any military charity.

Mailcall will distribute funds directly to the participating, established non-profit military organizations, based on their participation. These funds will then be used to meet their organization's mission such as providing medical care, food, shelter, childcare, counseling support, etc. Organizations such as The Fisher House, Home For Troops, Veterans for America, Yellow Ribbon, etc are the types of organizations that qualify for Mailcall proceeds.

Mailcall, is an online mass collaboration greeting card business. It solicits participation from the general public, tapping into an almost infinite wealth of talent and creativity, to design greeting cards. Anyone can submit their card design to the Mailcall website. Cards are voted on by the public and the best bubble to the top. People can buy a subscription to send these popular e-cards or printed cards to their friends and family. When they purchase the cards online they will be asked which charity they were referred by or want their contribution to go to, thus profits from greeting card sales and subscriptions will be distributed to the military charities that participate by spreading the word about Mailcall in order to raise funds for their cause.

No proceeds of the corporation will enrich any individual excep that reasonable compensation may be paid for services to the non-profit. If the non-profit is dissolved, any assests remaining will be distributed according to Rhode Island state law for non-profits.
