

Effective immediately, I, John J. Partridge, Esq., hereby resign as the registered agent of Pioneer Holdings, LLC in the State of Rhode Island.

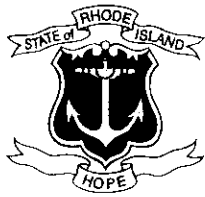
