2. The following amendment to the Articles of Incorporation was adopted by the corporation:

Amend “3. The specific purpose or purposes for which the corporation is organized are:” to read as follows:

“A non-profit organization dedicated to educating individuals, families, and groups such as elementary and secondary school students, hospital and clinic staffs, and other similar groups affected by or treating eating disorders, educating said individuals, families, and groups on the prevention of and treatment for eating disorders, as well as the availability of, and access to, quality treatment for those with eating disorders, and for any other exclusively charitable, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.”

Amend “4. Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these Articles of Incorporation for the regulation of the internal affairs of the corporation are: “to read as follows:

“Upon dissolution of the corporation all remaining assets shall be distributed to the National Eating Disorder Association (NEDA) or its successor, and in the event NEDA is no longer in existence, then to another qualified charitable organization under IRS Code Section 501 (c).”
