On October 21, 2009, the Rhode Island Superior Court in Providence County (the "Court") entered an Order, a copy of which is enclosed, appointing Joseph P. Ferrucci, Esq., the Permanent Receiver of JD Food corp. d/b/a C-Town Supermarket (the "Company"). On November 3, 2009, the Court entered an Order substituting W. Mark Russo, Esq. as Permanent Receiver of the Company, a copy of which is attached hereto.

A Receivership is a State Court-supervised liquidation proceeding. The Receiver is an Officer of the Court, appointed for the purpose of representing the interest of all creditors and parties in interest. The Receiver is currently continuing to operate the Company in a "business as usual" manner, with the authority of the Providence County Superior Court of Rhode Island. The Receiver is paying, and will continue to pay, post-receivership petition vendor bills and/or obligations in the ordinary course of business as any such debts mature or accrue.

If you have any pre-receivership petition vendor bills and/or obligations that you believe are due and owing from the Company, in order that your interests be protected in connection with this case, enclosed is a Proof of Claim form which, I suggest you complete, execute before a Notary Public and return to me at the earliest possible date so that you will be certain to receive notice of all aspects of this proceeding and your rights protected accordingly. The deadline for the Proof of Claim to be filed by me, as Receiver, is January 21, 2010.

No distribution to any creditors will take place without notice to all creditors and parties in interest of a hearing on any such sale or any such claims before the Rhode Island Superior Court.
