Term. The Partnership was organized pursuant to the Certificate and Agreement filed in the office of the Secretary of State of Rhode Island, on October 27, 1982, as amended, and shall continue until the earliest of (a) December 31, 2089; (b) the liquidation or dissolution of any corporate General Partner, the death, adjudication of insanity or incompetency of any individual General Partner, or the retirement, resignation, expulsion (as defined in Section 19.02) or Bankruptcy of any General Partner (as defined in Section 19.04), unless the Partnership is further continued in accordance with the provisions of Section 19; (c) the sale or other disposition by the Partnership (other than to a nominee) of all of its interest in the Project, including any mortgage or leasehold interest which may be acquired by the Partnership in exchange therefor; or (d) dissolution of the Partnership, unless the General Partners or the Limited Partner elect to continue the Partnership in accordance with the provisions of Section 19, herein.

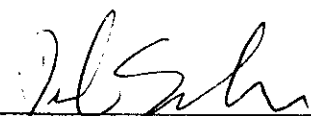
