The purpose of the thesis film fund is to enable the creation of a cross-cultural visual arts media collaboration that will take its final form in the shape of a short film.

The film uses the unique aspects of the film medium, namely image and sound to explore a set of universal inner problems within a very specific time and place in recent history.
