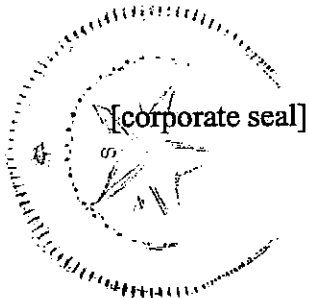
sign any and all documents necessary and relating to the filing of Fictitious Name, Trade Name, and Assumed Name Statements in all states (where applicable).
