AGREEMENT AND PLAN OF MERGER

This Agreement and Plan of Merger is by and between ETR Consulting, LLC, a Rhode Island limited liability company, (sometimes "ETR") and Quality Signatures, LLC, a Rhode Island limited liability company, (sometimes "Quality") as follows:

1. The constituent entities to the merger are ETR Consulting, LLC and Quality Signatures, LLC, both Rhode Island limited liability companies. ETR will be merged with and into Quality pursuant to R.I.G.L. §§ 7-16-59 et seq.
2. Quality Signatures, LLC shall be the surviving entity governed by the laws of the State of Rhode Island.
3. All of the member interests of ETR shall be converted into like membership interests in Quality. The same person owns all of the membership interests in both ETR and Quality.
4. The Articles of Organization of Quality shall continue without further change as the Articles of Organization of the surviving entity except that Article ONE shall be amended to read
The name of the limited liability company is Cycle Essence, LLC.
5. Quality shall pay all expenses to effect these transactions contemplated.
6. The merger shall be effective upon the filing of Articles of Merger with the Rhode Island Secretary of State.
