(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

#### **ARTICLE I**

The name of the corporation is The DAVE Project: Dedicated Artists for the Vitality of Arts Education

#### **ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

The organization is organized exclusively for charitable, educational and literary purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Inspired by the late David Gorgone's passion for performing arts, and fueled by the knowledge that arts education plays a key role in the preservation of our culture, we strive to supplement public education in Rhode Island by providing performing arts classes led by an established resident company of trained and working professionals at little to no cost for participants.
