Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Rhode Island Metro EMS Association, Inc

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

To serve the emergency medical service community by:

- Encouraging the development and implementation of sound policies and procedures for the emergency medical service (EMS) community.
- Acting as a clearinghouse for information on comprehensive EMS issues.
- Providing a forum for creative and innovative problem solving on EMS issues.
- Advocating for standards for EMS services and providers.
- Fostering informed decision-making on public policy pertaining to EMS.
- Establishing alliances between any and all Rhode Island EMS agencies for the exchange of ideas of mutual interest and concern.
