7. Generally to carry out at Scituate, Rhode Island, the principles and teachings of The International Association of Lions Clubs, a service club organization with whom Lions Club of Scituate, Rhode Island is affiliated.
8. That, except as herein limited, this corporation shall have and exercise all the powers granted to corporations by the laws of the State of Rhode Island.
9. To incorporate the unincorporated association known as the Lions Club of Scituate, Rhode Island.
