ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws of Rhode Island, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Nueva Generacion Cristiana of Rhode Island

2. The period of its duration is (if perpetual, so state) Perpetual

3. The specific purpose or purposes for which the corporation is organized are:
The establishment of a bible fundamental christian church in the state of Rhode Island for the ministry of
spiritual and human needs. For the organization of a corporate congregation of believers in the Lord Jesus
