## **LIMITED POWER OF ATTORNEY**

Be it known that Comtel Telecom Assets LP, a Texas limited partnership ("Comtel"), by its duly authorized representative named below, does hereby appoint Technologies Management, Inc., as attorney-in-fact to undertake only the following activities on behalf of Comtel:

Sign and file reports, and any related correspondence, prepared in accordance with the Compliance Reporting Agreement entered into between Comtel and Technologies Management, Inc. dated as of July 1, 2007 after those reports have been approved by a duly authorized representative of Comtel as specified and amended by the Addendum To Compliance Reporting Agreement between Comtel and Technologies Management, Inc. dated as of July 1, 2007. Said authority includes, but is not limited to, the express authority of the Attorney-in-fact to sign on behalf of any officers or employees of Comtel designated in the Addendum to Compliance Reporting Agreement between Comtel and Technologies Management, Inc. dated as of July 1, 2007. Copies of these two Agreements are attached hereto as Exhibits "A" and "B" respectively, and are incorporated by reference herein.

Comtel Telecom Assets LP hereby authorizes the following individuals, who are officers and/or employees of Technologies Management, Inc. to execute the aforesaid documents on behalf of Technologies Management, Inc. in its capacity as Attorney in Fact for Comtel Telecom Assets LP: Connie Wightman, President; Carey Roesel, Consultant; Monique Byrnes, Consultant; Sharon Thomas, Consultant; Thomas Forte, Consultant; Robin Norton, Consultant; Karen Hanson, Manager; and Phyllis Miller, Assistant Manager of Technologies Management, Inc., and any other any duly appointed Consultant of TMI (as evidenced by corporate resolution of Technologies Management, Inc.), which resolutions may be executed subsequent to the date of execution of this Limited Power of Attorney.

Third parties may rely on the representations of the attorney-in-fact as to all matters relating to the power granted to it hereunder, and unless provided with actual evidence that the powers have been terminated may rely upon the powers recited herein.

This Limited Power of Attorney is effective immediately and will continue in effect until revoked by written notice to the other party by either Comtel or Technologies Management, Inc. Notwithstanding the foregoing, this Limited Power of Attorney shall automatically be revoked as of the effective date of any termination of the Compliance Reporting Agreement entered into between Comtel and Technologies Management, Inc. dated as of July 1, 2007.

Comtel understands and agrees that Technologies Management, Inc. may serve as an attorney-in-fact for other companies in the same industry as Comtel and consents to such representation.

Comtel represents and warrants that (a) the execution, delivery and performance by it of this Limited Power of Attorney has been duly authorized by all necessary partnership action; and (b) the person signing this Limited Power of Attorney is duly authorized to execute, deliver, perform, and observe the provisions of this Limited Power of Attorney.

Comtel shall indemnify, defend and hold harmless Technologies Management, Inc. and its officers, directors, employees, and agents from and against any and all demands, losses, costs, damages,

assessments, injuries, expenses (including but not limited to reasonable attorneys' fees and costs), claims and liabilities (collectively, "Losses") which Technologies Management, Inc. may at any time sustain arising out of or attributable, directly or indirectly, in whole or in part, in connection with carrying out the authority expressly granted in this Limited Power of Attorney, provided such Losses are from actions taken by Technologies Management, Inc. that are wholly within the scope of this Limited Power of Attorney. Technologies Management, Inc. also shall not be liable for any fees, penalties, or interest assessed against Comtel in respect of a report signed by Technologies Management, Inc. as authorized by this Limited Power of Attorney but rejected by the recipient agency or its designated agent as a result of the exercise of this Limited Power of Attorney.

This Limited Power of Attorney will be governed by the laws of the state of Texas without regard for conflicts of law principles. It is intended to be valid in all jurisdictions both inside and outside of the United States of America.


