Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is The Thousand Alternatives Collective

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

to build domestic and international solidarity by supporting projects and organizations that work for social and environmental justice through transparent and horizontal means. The Collective will support these projects through financial aid, networking, and administrative tasks. The Collective will meet its own fiscal needs and the needs of projects it funds through a combination of fundraising, grants, and most importantly through running paid workshops, classes, and skill-shares. Using these collaborations, the Collective will create an open-source database of resources, organizations and tools to contextualize and connect past and future social change endeavors.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THAT THE COLLECTIVE WILL BE RUN THROUGH A HORIZONTAL CONSENSUS PROCESS. ALL MATTERS CONCERNING FINANCE, ADMINISTRATION, AND ORGANIZATION WILL BE DECIDED UPON DEMOCRATICALLY. SEPARATE COMMITTEES WILL FORM TO SUPPORT EACH PROJECT THAT IS INTERNALIZED BY THE COLLECTIVE, AND WILL COMMUNICATE WITH ALL MEMBERS ABOUT THE FULFILLMENT OF EACH PROJECT'S MISSION.
