Perform as a graphic designer for the creation of graphics and images to be used in album and DVDs covers, websites and printed material for the promotion and advertisement of artists, music shows and music products.

Design and build commercial and personal recording studios and operate as an acoustic consultant; to utilize and manage recording studios and music equipment for commercial purposes, schedule national and international artists to record their music for the exchange of money.

Sell and offer renting services of professional audio and video equipment; pyrotechnic and entertainment lighting equipment for temporary and permanent events for industries such as night clubs, bars, live shows,

concert arenas, film, television, theater, red-carpet media arrivals, fashion shows, tradeshow exhibits, themed environments, houses of worship, educational facilities, retail displays, corporate shows and other music related stages.

Provide music lesson and training: dance, choreography, music theory, songwriting, music composition, music recording and music engineering, music production and music marketing.
