Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is CHRIST CENTERED MARRIED COUPLES ASSOCIATION

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

To create and foster unity among married couples

To support the cause for Biblical marriage between a man and a woman

To promote solid Biblical principles of marriage

To eradicate divorce among married couples

To keep family together in peace and love

To support spiritual family growth through prayer, Bible study and family devotions

To provide counseling and conflict resolutions to our members free of charge

To provide the necessary teachings to keep love, unity, peace and understanding in marriage

To bring couples together to learn, have fun, and share with each other their successes and weaknesses

**ARTICLE IV**

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE INITIAL BOARD MEMBERS SHALL BE PERMANENT MEMBERS UNTIL DEATH OR BECOMES INCAPACITATED OR RESIGNED.

COUPLE CAN BECOME MEMBER OF THE BOARD.

ALL OTHER BOARD MEMBERS SHALL BE ELECTED BY A MAJORITY VOTE OR APPOINTED IF NECESSARY.
