(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Chronic Pain Management Centers of Rhode Island, Inc [CPMC]

DIRECTORS SHALL NOT HAVE PERSONAL LIABILITY TO THE CORPORATION OR TO ITS MEMBERS FOR MONETARY DAMAGES FOR BREACH OF A DIRECTORS DUTY IN HIS/HER CAPACITY AS A DIRECTOR, HOWEVER, THIS PROVISION DOES NOT ELIMATE OR LIMIT LIABILITY OF A DIRECTOR:

- 1. FOR ANY BREACH OF THE DIRECTORS DUTY OF LOYALTY TO THE CORPORATION OR ITS MEMBERS;
- 2. FOR ACTS OR OMMISIONS NOT IN GOOD FAITH OR WHICH INVOLVE INTENTIONAL MISCONDUCT OR A KNOWING VIOLATION OF LAW; OR
- 3. FOR ANY TRANSACTION FROM WHICH THE DIRECTOR DERIVED AN IMPROPER PERSONAL BENEFIT, AND ALSO INCLUDING ANY PROVISION WHICH UNDER CHAPTER 7-6 OF THE RHODE ISLAND GENERAL LAWS IS REQUIRED OR PERMITTED TO BE SET FORTH IN THE BY-LAWS.
