**ARTICLE I**

The name of the corporation is PFC KYLE JOSEPH COUTU MEMORIAL FUND

The specific purpose or purposes for which the corporation is organized are:

The PFC Kyle Joseph Coutu Memorial Fund is a corporation that will have a charitable purpose. This corporation will raise funds for charitable donations that will include (1) the advancement of education via grants and/or scholarships to high school students of Tolman High School, in Pawtucket Rhode Island, for the student's financial assistance with post-secondary education, (2) erecting and maintaining public monuments in honor of PFC Kyle Joseph Coutu, and (3) relief of the poor and/or underprivileged through donations and/or grants towards equipment and expenses for school athletic programs at Tolman High School in Pawtucket, Rhode Island.
