4. That said Receiver is hereby discharged and the Receivership Bond ordered cancelled;

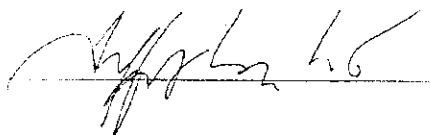
5. That SCT is hereby ordered dissolved and the Receiver is directed to forward a copy of this Order to the Office of the Secretary of State for the State of Rhode Island;

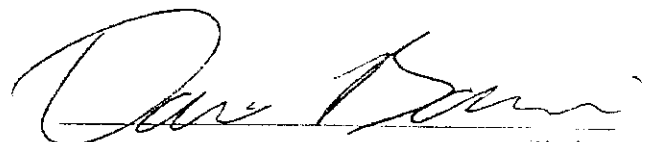
6. That this proceeding is now closed, and may be reopened only upon the filing of a motion.

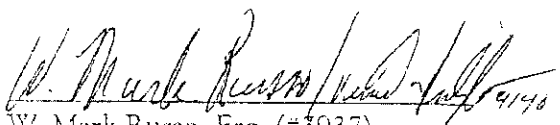

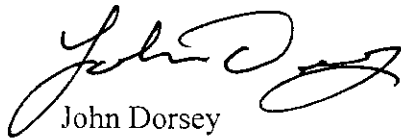
