Articles of Incorporation of Safer Institute

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Rhode Island, do hereby certify:

First: The name of the Corporation shall be the Safer Institute.

Second: The place in this state where the principal office of the Corporation is to be located is the City of Providence, RI, Providence County.

Third: Said corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The Safer Institute intends to perform and create, based upon research of best practices, software solutions for public health and disaster response in order to assist the public with issues such as public health, public safety, and emergency preparedness and response. Safer Institute will create and provide informatic solutions to governmental, non-governmental, and non-profit entities on issues such as public health, public safety, emergency preparedness, disaster response and other important issues facing our society.
