TO CREDITORS AND OTHER PARTIES IN INTEREST:

Re: Homeco International, Inc.

On October 7, 2010, the Rhode Island Superior Court, sitting in Providence County (the "Court"), entered an Order appointing the undersigned as Temporary Receiver of the assets of Homeco International, Inc. ("Homeco"). Homeco operated an importing and distribution business of paint supplies and hand tools with an office located at 90 Industrial Circle, Lincoln, Rhode Island. All business operations terminated prior to the appointment of a Receiver.

As the Receiver, I am an Officer of the Court, appointed to represent the interests of <u>all creditors and parties in interest</u>. I do not now, nor have I ever represented Homeco or its stockholders. I have been appointed as a neutral and impartial Receiver for the purpose of marketing and selling the assets of Homeco for the highest value, in order to maximize recovery for creditors.

Preliminarily, it appears that Homeco has secured debt of approximately \$444,000, no priority tax debt, and general unsecured debt in the amount of approximately \$650,000.

In connection with the Receivership, as set forth in Paragraph 6 of the enclosed <u>Order Appointing Temporary Receiver</u>, all creditors are enjoined and stayed from taking any action to enforce their claims against Homeco and/or its assets.

No claims will be approved and no distribution to creditors will take place without notice to all creditors and other parties in interest who file a <u>Proof of Claim</u> with the Receiver, after a Hearing thereon before the Rhode Island Superior Court.
